## RELEASE & WAIVER

**I AGREE in consideration for my participation in the event to the following:**

I AGREE that I am voluntarily participating in this Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, auditors or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the event involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I AGREE to release Greenfield International Imports & Training facility and Schooling Show from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm cause by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting the negligence of Greenfield International Imports and Training, the Facility, or Schooling Show.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) Greenfield International Imports and Training Schooling Show and to hold it harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the event.

I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that Greenfield International Imports and Training Schooling Show strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian or a junior exhibitor, I consent to the child/s participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.

I AGREE that "the event" and "Greenfield International Imports and Training Schooling Show" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers, auditors and affiliated organizations.

I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

In accordance with the Wisconsin Law relating to the limitation of civil liability regarding equine activities:

"NOTICE: A person who is engaged for compensation in the rental of equines or equine equipment or tack or in the instruction of a person in the riding or driving of an equine or in being a passenger upon an equine is not liable for the injury or death of a person involved in equine activities resulting from the inherent risks of equine activities, as defined in section 895.481 (1)(e) of the Wisconsin Statutes."
